Board President/Mayor Pro Tem Eversmeyer called the Special Board of Aldermen Meeting to order, declared a quorum present and led in the Pledge of Allegiance.

Treasurer Flinn stated that the budget amendment may not be needed and requested Jennifer Anders of Woodard & Curran to explain. Jennifer Anders stated that both Work Order Nos. 001 and 002 will not be completed for sixty days and can be invoiced after July 1st.

Ms. Anders continued that Work Order No. 001 was for data analysis on existing conditions at the wastewater facilities in three phases. The analysis is only partially completed due to the lack of flow data necessitating Work Order 002. Rain flow data needs to be collected and monitored for sixty days to address recurring overflow violations at the Highway 47 sewer plant occurring when rain fills lagoon and spills out of manhole covers. The flow data will also be used to determine how much flow needs to be diverted to the membrane plant.
