

**City of Troy, Missouri**  
**Public Hearing and Special Board of Aldermen Meeting**  
**Thursday, August 27, 2015**  
**6:30 P.M.**

Present for the meeting were Aldermen Eversmeyer, Detert, Sconce, Anderson and Mayor Cross. Alderman Bass was not present. Also present were City Attorney Granneman and City Clerk Schneider.

Mayor Cross opened the Public Hearing. The purpose of the Public Hearing was for citizen input on the proposed Property Tax Rate for 2015 to be set by the City of Troy, a political subdivision. There was no citizen input.

Mayor Cross called the Special Board of Aldermen Meeting to order, declared a quorum present, and led in the Pledge of Allegiance.

Alderman Detert made a motion, seconded by Alderman Eversmeyer to Accept the Resignation of Ron Walters, Ward III Alderman. Vote: Detert aye, Eversmeyer aye, Anderson aye, Sconce aye.

Alderman Eversmeyer made a motion, seconded by Alderman Detert to Appoint Todd Walker as Alderman, Ward III, Unexpired One-Year Term as Recommended by Mayor Cross. Vote: Eversmeyer aye, Detert aye, Anderson aye, Sconce aye.

Alderman Walker was sworn in by City Clerk Schneider.

Alderman Anderson made a motion, seconded by Alderman Sconce to Approve and Set Property Tax Rate Per \$100.00 Assessed Valuation of \$0.1900 for Tax Year 2015. Vote: Anderson aye, Sconce aye, Walker aye, Eversmeyer aye, Detert aye.

Alderman Sconce made a motion, seconded by Alderman Eversmeyer to Approve and Authorize Mayor to File Application for any State and Federal Disaster Assistance Related to Public Assistance Declared August 7, 2015 for Incidents of Severe Storms, Tornadoes, Straight-line Winds and Flooding from May 15, 2015 to July 27, 2015. Vote: Sconce aye, Eversmeyer aye, Anderson aye, Walker aye, Detert aye.

Alderman Eversmeyer made a motion, seconded by Alderman Sconce to Go Into Closed Session in compliance with 610.021 of RSMo., for the purposes of discussing Legal and Personnel. Vote: Eversmeyer aye, Sconce aye, Detert aye, Anderson aye, Walker aye.

City Attorney Granneman advised on Legal Matters.

City Clerk Schneider confirmed Light Duty for Officer Ryan Parker due to worker's compensation claim.

Alderman Detert made a motion, seconded by Alderman Eversmeyer to go out of Closed Session. Vote: Detert aye, Eversmeyer aye, Walker aye, Sconce aye, Anderson aye.

Alderman Sconce made a motion, seconded by Alderman Anderson to adjourn the meeting. Vote: Sconce aye, Anderson aye, Walker aye, Eversmeyer aye, Detert aye. Meeting adjourned 6:59 p.m.
