

Inspections

During the construction process, inspections are performed at various stages of construction to insure compliance. **All inspections must be requested 24 hrs in advance by calling 636-528-1254**. All inspections will be given an A.M. or P.M. time Only footing inspections will be given a specific time. You must provide the permit number when requesting an inspection. Additional information needed is the type of inspection, lot number and subdivision and the name and phone number of the contact person should there be any questions.

If a contractor fails to schedule an inspection and continues working without the required inspection, A "Stop Work Order" will be issued until the inspection is completed and a fine of \$500.00 will be charged to the permit. This fine must be paid prior to the next inspection. During each inspection, the Erosion and Sedimentation Control Devices will be inspected to ensure that they are in place. If not, a stop work order will be issued.
