## BOARD OF ADJUSTMENT PUBLIC HEARING July 6, 2023, 8:30 A. M.

Witte Brothers Exchange, Inc., applicant, is requesting a building height variance from 35 feet in building height to 55 feet in building height, under Article 405.130, Part 5. This site is located at 575 Witte Industrial Court.

Chris Silverberg, Mick Durr, and Brett Pfeiffer, residents of Westhampton Woods Subdivision, expressed concern over how the lights, water drainage, noise, and view coming from Witte Brothers Exchange, Inc. is affecting the residents of Westhampton Woods. Chris Silverberg asked that the variance not be approved until their concerns were addressed.

Alternate Board Member Wyatt asked the residents if their concerns were addressed would they be ok with the approval of the variance. Chris Silverberg responded that they would be fine with the approval if their concerns were addressed.

David Lindsey, Building Official, stated that the Planning and Zoning Board would be the forum where these concerns should be addressed, and the building height variance was all that could be discussed in this meeting. The residents expressed additional concerns over the height of the building. Brad Pfeiffer said that light travels further at 55 feet high than at 35 feet high.

Brent Witte, Witte Brothers Exchange, Inc., stated that he had never been contacted by the Westhampton Woods residents and that Witte Brothers Exchange, Inc. wants to be good neighbors. He said he would be happy to speak with the residents and hopefully find a solution. Residents agreed to meet with Brent Witte to discuss a solution.

#### A. Variance-23-0002

Witte Brother Exchange, Inc., applicant, is requesting a building height variance from 35 feet in height to 55 feet in height. This site is located at 575 Witte Industrial Court.

The board held a discussion with questions for Witte Brothers Exchange, Inc. and the residents of Westhampton Woods.

Chris Silverberg stated this board should not approve the building height variance until Witte Brothers Exchange, Inc. complied with regulations and addressed the concerns of Westhampton Woods Subdivision residents.

Colleen Davis, Westhampton Woods Subdivision resident, asked what the noise increase in decibels would be from the refrigeration units on the building. Brent Witte said he could check into the decibel increase and provide an answer.

Chris Silverberg asked what the increase in fleet size would be. Brent Witte responded that the fleet would increase by roughly 20% and the building would also act as a buffer for noise. He also stated that their trucks are usually plugged in and not running on the lot. Mr. Witte also offered to provide his personal phone number to the residents to further discuss a solution.

Brent Witte, Witte Brothers Exchange, Inc., and the Westhampton Woods residents agreed to meet immediately following this meeting to discuss solutions to the concerns of the Westhampton Woods residents.
